

Public notice

The Essex County Council (The Endway, Steeple Bumpstead) (Temporary Prohibition of Traffic) Order 2016

Notice is hereby given that the Essex County Council intends, not less than seven days from the date of this notice, to make the above Order under section 14(1) of the Road Traffic Regulation Act 1984.

Effect of the order: To temporarily close that length of The Endway in the Parish of Steeple Bumpstead in the District of Braintree from a point 250m east of the junction with Bumpstead Road for a distance of 5m east.

The closure is scheduled to commence on 31st October 2016 for three days or where appropriate signs are showing and weather permitting.

The closure is required for the safety of the public and workforce while replacement of Fire Hydrant is undertaken.

The alternative route will be via B1054 Blois Road, A1017 Rowley Hill, A1017, B1057 Bumpstead Road and vice versa.

Access for emergency service vehicles and pedestrians will be maintained at all times during the closure.

The Order will come into effect on 31st October 2016 and may continue in force for 18 months or until the works have been completed, whichever is the earlier.
